Section 110 Surveys Project: FY23 Cooperative Agreement Cycle Projects

Contracting Section 110 Projects

NPI intends to contract out Section 110 projects (*project descriptions may be subject to change*) at the following installations during our FY23 cooperative agreement cycle.

Section 110 Projects: FY23 Cooperative Agreement Cycle

• **Andersen Air Force Base, Guam**

Evaluate potential National Register eligibility of selected World War II-era buildings and structures

• **Army Reserve, Texas**

Architectural and archaeological surveys at various installations

• **Fort Cavazos, Texas**

Provide a National Register evaluation for 50 potentially historic structures and buildings associated with training infrastructure from WWII, Korea, and Vietnam

• **Fort Moore Army Base, Georgia**

Conduct an architectural survey of 34 buildings and structures at ranges along Dixie Road

• **MacDill Air Force Base, Florida**

Conduct additional archaeological surveys at Port Tampa Cemetery, including non-invasive geomorphological testing, to refine horizontal and vertical boundary information and to develop a management and site protection plan

• **Marine Corps Air Station, Beaufort, South Carolina**

Conduct a Phase 1 Archaeological Survey of up to 400 acres within the Townsend Bombing Range in southeastern Georgia

• **Vandenberg Space Force Base, California**

Conduct archaeological studies suitable to prepare National Register evaluations of five historic period archaeological sites

Deadline for CRM Firms to Submit Expression of Interest

The deadline for CRM firms to submit an expression of interest is **January 30, 2024**, two weeks from the date the FY23 cooperative agreement cycle projects are posted.

Information Required from CRM Firms to Submit an Expression of Interest

CRM firms with suitable expertise and experience are invited to submit an expression of interest in a project(s), along with their qualifications to conduct a specific Section 110 project(s). NPI will be in contact with all contractors who submit the required information.

To submit an expression of interest, send an email to Jere Gibber and John Sprinkle at info@npi.org with the following required information. *Do not send information other than specific requirements.*

1. Project name(s)
2. Name of firm
3. Contact: Name, title, telephone, email
4. Qualifications
 - A. If you have already submitted qualifications, note the date sent
 - B. If you have not yet submitted qualifications, the following information is required:
 - i. 10-page maximum submission
 - ii. Contact information: name, title, firm name, telephone, email
 - iii. Statement of firm's professional capabilities
 - iv. List of previous Section 110-type work projects for DoD or other organizations
 - v. Geographic areas of firm's expertise
5. Additional qualifications information pertinent to a specific project, if not already included in previously submitted materials (maximum 2 pages per project)
