The Preservation Roundtable is an informal gathering of historic preservation professionals and advocates founded in February 1969 by Fritz Gutheim. The Roundtable encourages a broad and vigorous discussion of topics important to historic preservation. Noted in *Keeping Time* by Roundtable cofounder William J. Murtagh, the luncheon is now a preservation institution in itself.

Besides libations, lunch, and opportunities to meet fellow professionals, the Roundtable provides an opportunity to introduce guests and make announcements about historic preservation activities. The Roundtable meets at The Arts Club of Washington (2017 I Street, NW, Washington, DC). Members receive notices by email and reservations are requested by the Friday prior to each event.

In 2020, Roundtable will offer four luncheons and two evening gatherings:

- *Wednesday, April 29, 6-8 p.m., evening gathering*
- *Wednesday, May 27, 12 noon, luncheon*
- *Wednesday, September 23, 12 noon, luncheon*
- *Wednesday, October 21, 6-8 p.m., evening gathering*
- *Wednesday, December 16, 12 noon, luncheon*

The cost of lunch is \$35 and includes salad or soup, main course, dessert, coffee, and drinks. The cost for evening gatherings is \$35 for *hors d'oeuvres* and non-alcoholic beverages; alcoholic beverages will be available at a cash bar. Event charges are payable by the day of the event. Members who make reservations and do not attend are billed. A special one-time rate of \$25 is available for young professionals, interns, and graduate students.
